MEMORANDUM OF UNDERSTANDING

This **Memorandum of Understanding** (hereinafter called as the 'MOU') is entered into on this **7**th day of JULY – Two Thousand Twenty One (2021), by and between

AND

FIT Group of Institutions, Meerut having its registered office at Kaseru Buxar, Green Park, Mawana Road, Meerut – 250001, Uttar Pradesh, India is accredited from AICTE and it is affiliated to Dr. APJ Abdul Kalam Technical University, Lucknow & Ch. Charan Singh University, Meerut, is referred to as "Second Party" company (which expression shall unless repugnant to the context, includes its successors and assignees of the Second Party.

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

WHEREAS:

- A) First Party is Turacoz Healthcare Solutions Private Limited, Gurugram, Haryana.
- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within areas of Summer Training/ Internship, Job Oriented Training (Integrated programs for increasing Employability Skills for Students.
- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.
- E) FIT Group of Institutions, Meerut the Second Party is engaged in 14 courses across 5 streams namely IT, Management, Engineering, Education, Physical Education and across 9 degrees like B.Tech, B.P.Ed, BA, BBA, BCA, B.Com and many more programs.



FIT Group of Institutions having its institutes in KaseruBuxar, Green Park, Mawana Road, Meerut — 250001, Uttar Pradesh, India is NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1 CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the First Party providing significant inputs to them in developing suitable training systems, keeping in mind the needs of the industry, the Second Party.

CLAUSE 2 SCOPE OF THE MoU

- 2.1 Free Training/ Internship, Job Oriented Training Integrated programs.
- 2.2 Industrial Training: 45 days at Turacoz Healthcare Solutions Private Limited Premises.
- 2.3 Depending on the requirement, training can be customized.
- 2.4 Industrial Visits: The First Party will provide Free Industrial Visits; First party will also provide hands-on training to the learners enrolled with the Second Party.



- 2.5 **Faculty Development Programs:** First Party to train the Faculties of Second Party for imparting training as per the industrial requirement.
- 2.6 Placement of Trained Students: Placement of Students will only be given on 7-12 months integrated programs. The First Party will actively engage for the delivery of the training and placement of students of the Second Party.
- 2.7 First party will provide Course material for Industrial Training and 12 months integrated programs/.
- 2.8 First party will require Permission and Space for two banners in college premises during the MOU period.
- 2.9 First party will require space at the College notice board during the MOU period.
- 2.10 **Batch Information and Training Calendar:** First Party will send Batch Plan and Training Calendar on mutual agreed training plan with dates.
- 2.11 Appointment of a dedicated Nodal person will have to be done by SECOND PARTY. The Nodal Person will provide Weekly/Monthly updates to the First Party.
- 2.12 Marketing Support: First party will provide Marketing activities like banners, brochures and leaflets which can also be distributed within Second Party premises to promote registration of Students. The Institute's website will be updated for the new offerings with mutually agreed fees structure. First party will provide marketing support like Posters, Mailers and banners.
- 2.13 It will be the responsibility of the Second Party to have a registration desk to facilitate registration for Training & Job Oriented Integrated Programs..

CLAUSE 3 INTELLECTUAL PROPERTY

- 3.1. Each Party hereby grants to the other, the non-exclusive license rights to use its name/ logo for the purpose of promoting the course and activities under this MOU through public advertisements and through various means including print, electronic, radio, banners, wall painting, etc. for the term. Rights and designs of the other Party.
- 3.2. Each Party acknowledges and agrees that they shall not use in any manner the brand, name, logo or other intellectual property of the other Party nor permit any third person to do so without the prior written permission of the other Party and subject to any conditions attracted to



CLAUSE 4

VALIDITY

- 4.1 The validity of this MoU shall be One Year from the date of signing the same and thereafter extended through mutual consent.
- 4.2 MoU can be terminated on Any unauthorized disclosure of the Confidential Information by the Parties.
- 4.3 Both Parties shall return all Confidential Information which is in the custody of such Party upon termination/ expiry of this MOU and shall not make or retain any copies or record of any Confidential Information, and shall notify the other Party promptly of any unauthorized or improper use or disclosure of the Confidential Information.
- 4.4 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations
